Description

The *Edgewood Social Distancing Floor Sticker* is composed of two layers:

The lower printed vinyl layer is a 3.2 Mil (80 Micron) calendared film with brilliant gloss finish for enhancing print quality. The back is coated with a tinted, solvent-based, pressure-sensitive release adhesive that features quick and easy removal of up to one year in either dry or wet interior applications.

The upper layer is an additional 3 Mil protective wear layer made of polymeric facestock also featuring high gloss with UV inhibitors that adds outstanding clarity while providing protection and extending the life of your printed graphic.
